# **Contest Rules**

#### DeLong's Spirit of IPPE 2025 Giveaway Competition Rules

#### 1. Eligibility:

The DeLong's Spirit of IPPE 2025 Giveaway (the "Contest") is open to individuals who are legal residents of the United States, aged 18 years or older at the time of entry.

Employees of DeLong's and their immediate family members are not eligible to participate in the Contest.

#### 2. Contest Period:

The Contest will begin on November 20, 2024, and all entries must be received by January 30, 2025. The winner will be announced on February 7, 2025.

#### 3. How to Enter:

To enter the Contest, participants must complete the entry form provided by DeLong's, which will be available on their website or designated platform. Participants must provide their full name, email address, company address, and state information. Additionally, they must follow DeLong's company account on LinkedIn or Facebook. Both steps must be taken to qualify.

## 4. Judging Criteria:

All eligible entries will be entered into a random drawing. Three random drawings will be done for each prize in order. Should any entries become invalid, new drawing will occur.

#### 5. Prize:

The winner will receive a prize package valued at no more than \$50.

The value of the prizes may differ depending on the prize. We reserve the right to make changes should the prizes no longer become available and find a comparable prize with equal or lesser value.

One prize per winner. Winners will be validated and then contacted.

## 6. Winner Notification:

The winner will be notified via email or direct message within 48 hours of the winner selection on February 7, 2025.

The winner will need to respond within five (5) business days to claim the prize. Failure to respond within the specified time will result in the selection of an alternate winner.

#### 7. Prize Conditions:

The winner must provide all necessary personal information and any other required documentation to claim the prize.

The prize is non-transferable and may not be redeemed for cash or any other alternatives.

#### 8. Publicity Release:

By accepting the prize, the winner agrees to allow DeLong's to use their name, likeness, and entry for promotional purposes without additional compensation.

#### 9. General Conditions:
